

**PhillipMart (Pre-IPO Trading System)  
Announces Pre-IPO Share Price of  
Strong Petrochemical Holdings Limited (stock code: 00852)**

(Hong Kong – 9 January 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Strong Petrochemical Holdings Limited** (“the Company”; stock code: 00852). The IPO issue, to debut trading on Monday, its offer price has been fixed at HK\$2.50.

Pre-IPO closing price for the Company traded on **PhillipMart**, an automated electronic platform for pre-IPO shares trading, was HK\$2.76, 10.4% higher than its offer price HK\$2.50. The price opened at HK\$2.60, with a high-low range of HK\$2.76 and HK\$2.60. The most actively traded price was HK\$2.60 with a turnover of 13,000 shares. The total trading volume reached 50,000 shares with total turnover of HK\$133,530.00.
