



**PhillipMart (Pre-IPO Trading System)

The IPO issue, to debut trading tomorrow, its offer price has been fixed at HK\$1.05.

Pre-IPO closing price for the Company traded on **PhillipMart**, an automated electronic platform for pre-IPO shares trading, was HK\$1.08, 2.86% higher than its offer price HK\$1.05. The price opened at HK\$1.15, with a high-low range of HK\$1.15 and HK\$1.06. The most actively traded price was HK\$1.10 with a turnover of 40,000 shares. The total trading volume reached 106,000 shares with total turnover of HK\$116,100.00.
