



**PhillipMart (Pre-IPO Trading System)
Announces Pre-IPO Share Price of
Real Gold Mining Limited (stock code: 00246)**

(Hong Kong – 20 February 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Real Gold Mining Limited** (“the Company”; stock code: 00246). The IPO issue, to debut trading on Monday, its offer price has been fixed at **HK\$6.25**.

Pre-IPO closing price for the Company traded on **PhillipMart**, an automated electronic platform for pre-IPO shares trading, was **HK\$6.91**, **10.56%** higher than its offer price **HK\$6.25**. The price opened at **HK\$7**, with a high-low range of **HK\$7** and **HK\$6.77**. The most actively traded price was **HK\$6.85** with a turnover of **427,000** shares. The total trading volume reached **1,791,000** shares with total turnover of **HK\$12,276,765**.
