



**PhillipMart (Pre-IPO Trading System)

The IPO issue, to debut trading tomorrow, its offer price has been fixed at HK\$1.12.

Pre-IPO closing price for the Company traded on **PhillipMart**, an automated electronic platform for pre-IPO shares trading, was HK\$1.17, 4.46% higher than its offer price HK\$1.12. The price opened at HK\$1.10, with a high-low range of HK\$1.17 and HK\$1.10. The most actively traded price was HK\$1.10 with a turnover of 150,000 shares. The total trading volume reached 236,000 shares with total turnover of HK\$265,620.00.
