

**PhillipMart Announces Pre-IPO Share Price of
China Zhongwang Holdings Limited (stock code: 01333)**

(Hong Kong – 7 May 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China Zhongwang Holdings Limited** (“the Company”; stock code: 01333) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for the Company on PhillipMart were HK\$7.1 and HK\$6.78. The price closed at HK\$6.8 per share, 2.86 % lower than its offer price of HK\$7.0. The price opened at HK\$7.10, with the most actively traded price of HK\$6.80 per share, and a turnover of 214,800 shares. The total trading volume reached 700,800 shares with total turnover of HK\$4,840,460. The final price of the Company’s shares, to debut trading tomorrow, has been fixed at HK\$7 per share.

The trading hours of **PhillipMart** has been updated from **4:30pm to 6:00pm** (previous trading hours was from 4:45pm to 6:15pm), effective from Monday, 30 March 2009.
