

PhillipMart Announces Pre-IPO Share Price of Chigo Holdings Limited (Stock code: 00449)

(Hong Kong – 9 July 2009) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Chigo Holdings Limited ("the Company"; stock code: 00449) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for the Company on PhillipMart were HK\$2.87 and HK\$2.52. The price closed at HK\$2.87 per share, 26.43% higher than its offer price of HK\$2.27. The price opened at HK\$2.70, with the most actively traded price of HK\$2.67 per share, and a turnover of 268,000 shares. The total trading volume reached 2,248,000 shares with total turnover of HK\$6,143,260.00. The final price of the Company's shares, to debut trading on Monday, has been fixed at HK\$2.27 per share.

The trading hours of PhillipMart has been updated from 4:30pm to 6:00pm (previous trading hours was from 4:45pm to 6:15pm), effective from Monday, 30 March 2009.
