

PhillipMart Announces Pre-IPO Share Price of BBMG Corporation (Stock code: 02009)

(Hong Kong – 28 July 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **BBMG Corporation** ("BBMG"; stock code: 02009) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for BBMG on PhillipMart were HK\$10.40 and HK\$9.00. The price closed at HK\$10.36 per share, 62.38% higher than its offer price of HK\$6.38. The price opened at HK\$9.00, with the most actively traded price of HK\$9.95 per share, and a turnover of 1,939,500 shares. The total trading volume reached 13,270,500 shares with total turnover of HK\$132,366,190.00. The final price of the BBMG's shares, to debut trading tomorrow, has been fixed at HK\$6.38 per share.

The trading hours of **PhillipMart has been updated from 4:30pm to 6:00pm** (previous trading hours was from 4:45pm to 6:15pm), effective from Monday, 30 March 2009.
