

PhillipMart Announces Pre-IPO Share Price of Modern Media Holdings Limited (Stock code: 00072)

(Hong Kong – 8 September 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Modern Media Holdings Limited** ("Company"; stock code: 00072) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for the Company on PhillipMart were HK\$1.46 and HK\$1.34. The price closed at HK\$1.38 per share, 6.98% higher than its offer price of HK\$1.29. The price opened at HK\$1.46, with the most actively traded price of HK\$1.4 per share, and a turnover of 998,000 shares. The total trading volume reached 3,428,000 shares with total turnover of HK\$4,735,880.00. The final price of the Company's shares, to debut trading tomorrow, has been fixed at HK\$1.29 per share.
