

# PhillipMart Announces Pre-IPO Share Price of

# Peak Sport Products Co. Limited (Stock code: 01968)

(Hong Kong – 28 September 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Peak Sport Products Co. Limited** ("Company"; stock code: 01968) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Company on PhillipMart were HK\$3.73 and HK\$3.61. The price closed at HK\$3.62 per share, 11.71% lower than its offer price of HK\$4.10. The price opened at HK\$3.70, with the most actively traded price of HK\$3.62 per share, and a turnover of 145,000 shares. The total trading volume reached 600,000 shares with total turnover of HK\$2,191,960.00. The final price of Company, to debut trading tomorrow, has been fixed at HK\$4.10 per share.
