

**PhillipMart Announces Pre-IPO Share Price of  
 Ausnutria Dairy Corporation Limited (Stock code: 01717)**

(Hong Kong – 7 October 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Ausnutria Dairy Corporation Limited** (“Company”; stock code: 01717) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Company on PhillipMart were HK\$4.23 and HK\$4.06. The price closed at HK\$4.07 per share, 1.75% higher than its offer price of HK\$4.00. The price opened at HK\$4.20, with the most actively traded price of HK\$4.20 per share, and a turnover of 304,000 shares. The total trading volume reached 719,000 shares with total turnover of HK\$2,981,230.00. The final price of Company, to debut trading tomorrow, has been fixed at HK\$4.00 per share.
