

**PhillipMart Announces Pre-IPO Share Price of
 Yingde Gases Group Company Limited (Stock code: 02168)**

(Hong Kong – 7 October 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Yingde Gases Group Company Limited** (“Company”; stock code: 02168) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Company on PhillipMart were HK\$7.10 and HK\$6.75. The price closed at HK\$7.02 per share, 0.29% higher than its offer price of HK\$7.00. The price opened at HK\$6.78, with the most actively traded price of HK\$7.00 per share, and a turnover of 290,000 shares.
