

**PhillipMart Announces Pre-IPO Share Price of
 Greens Holdings Limited (Stock code: 01318)**

(Hong Kong – 5 November 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Greens Holdings Limited** (“Company”; stock code: 01318) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for the Company on PhillipMart were HK\$2.05 and HK\$1.82. The price closed at HK\$1.99 per share, 22.84% higher than its offer price of HK\$1.62. The price opened at HK\$1.82, with the most actively traded price of HK\$1.98 per share, and a turnover of 758,000 shares. The total trading volume reached 3,054,000 shares with total turnover of HK\$6,032,840.00. The final price of the Company, to debut trading tomorrow has been fixed at HK\$1.62 per share.
