

PhillipMart Announces Pre-IPO Share Price of Mingfa Group (International) Company Limited (Stock code: 00846)

(Hong Kong – 12 November 2009) Phillip Securities (HK) Ltd. ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Mingfa Group (International) Company Limited ("Company"; stock code: 00846) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for the Company on PhillipMart were HK\$2.49 and HK\$2.19. The price closed at HK\$2.40 per share, 0.42% higher than its offer price of HK\$2.39. The price opened at HK\$2.49, with the most actively traded price of HK\$2.40 per share, and a turnover of 624,000 shares. The total trading volume reached 3,017,000 shares with total turnover of HK\$7,081,680.00. The final price of the Company, to debut trading tomorrow has been fixed at HK\$2.39 per share.
