

PhillipMart Announces Pre-IPO Share Price of

China Tontine Wines Group Limited (Stock code: 00389)

(Hong Kong – 18 November 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Tontine Wines Group Limited** ("Tontine Wines"; stock code: 00389) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Tontine Wines on PhillipMart were HK\$1.71 and HK\$1.44. The price closed at HK\$1.51 per share, 20.80% higher than its offer price of HK\$1.25. The price opened at HK\$1.60, with the most actively traded price of HK\$1.50 per share, and a turnover of 5,112,000 shares. The total trading volume reached 13,594,000 shares with total turnover of HK\$20,389,860.00. The final price of Tontine Wines, to debut trading tomorrow has been fixed at HK\$1.25 per share.
