

## PhillipMart Announces Pre-IPO Share Price of

### Sany Heavy Equipment International Holdings Limited (Stock code: 00631)

(Hong Kong – 24 November 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Sany Heavy Equipment International Holdings Limited** ("Company"; stock code: 00631) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Company on PhillipMart were HK\$5.79 and HK\$5.50. The price closed at HK\$5.77 per share, 20.21% higher than its offer price of HK\$4.80. The price opened at HK\$5.50, with the most actively traded price of HK\$5.72 per share, and a turnover of 1,491,000 shares. The total trading volume reached 8,120,000 shares with total turnover of HK\$46,417,950.00. The final price of Company, to debut trading tomorrow has been fixed at HK\$4.80 per share.
