

**PhillipMart Announces Pre-IPO Share Price of  
 Fantasia Holdings Group Co., Limited (Stock code: 01777)**

(Hong Kong – 24 November 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Fantasia Holdings Group Co., Limited** (“Fantasia Holdings”; stock code: 01777) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Fantasia Holdings on PhillipMart were HK\$2.46 and HK\$2.32. The price closed at HK\$2.45 per share, 12.39% higher than its offer price of HK\$2.18. The price opened at HK\$2.36, with the most actively traded price of HK\$2.40 per share, and a turnover of 5,662,500 shares. The total trading volume reached 25,651,500 shares with total turnover of HK\$61,429,995.00. The final price of Fantasia Holdings, to debut trading tomorrow has been fixed at HK\$2.18 per share.
