

PhillipMart Announces Pre-IPO Share Price of Sands China Ltd. (Stock code: 01928)

(Hong Kong – 27 November 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Sands China Ltd.** ("Sands China"; stock code: 01928) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Sands China on PhillipMart were HK\$9.00 and HK\$8.60. The price closed at HK\$9.00 per share, 13.29% lower than its offer price of HK\$10.38. The price opened at HK\$8.60, with the most actively traded price of HK\$8.90 per share, and a turnover of 218,800 shares. The total trading volume reached 800,400 shares with total turnover of HK\$7,104,608.00. The final price of Sands China, to debut trading on Monday has been fixed at HK\$10.38 per share.
