

## PhillipMart Announces Pre-IPO Share Price of

## China Forestry Holdings Co., Ltd. (Stock code: 00930)

(Hong Kong – 2 December 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Forestry Holdings Co., Ltd.** ("China Forestry"; stock code: 00930) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Forestry on PhillipMart were HK\$2.25 and HK\$2.15. The price closed at HK\$2.18 per share, 5.31% higher than its offer price of HK\$2.07. The price opened at HK\$2.25, with the most actively traded price of HK\$2.18 per share, and a turnover of 2,348,000 shares.
