

## PhillipMart Announces Pre-IPO Share Price of Kaisa Group Holdings Ltd. (Stock code: 01638)

(Hong Kong – 8 December 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of Kaisa Group Holdings Ltd. ("Kaisa"; stock code: 01638) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Kaisa on PhillipMart were HK\$3.74 and HK\$3.49. The price closed at HK\$3.68 per share, 6.67% higher than its offer price of HK\$3.45. The price opened at HK\$3.50, with the most actively traded price of HK\$3.73 per share, and a turnover of 271,000 shares. The total trading volume reached 2,374,000 shares with total turnover of HK\$8,679,910.00. The final price of Kaisa, to debut trading tomorrow has been fixed at HK\$3.45 per share.
