

PhillipMart Announces Pre-IPO Share Price of China Corn Oil Company Limited (Stock code: 01006)

(Hong Kong – 17 December 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Corn Oil Company Limited** ("China Corn Oil"; stock code: 01006) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Corn Oil on PhillipMart were HK\$4.43 and HK\$4.10. The price closed at HK\$4.36 per share, 21.45% higher than its offer price of HK\$3.59. The price opened at HK\$4.38, with the most actively traded price of HK\$4.35 per share, and a turnover of 939,000 shares. The total trading volume reached 7,786,000 shares with total turnover of HK\$33,589,570.00. The final price of China Corn Oil, to debut trading tomorrow has been fixed at HK\$3.59 per share.
