

**PhillipMart Announces Pre-IPO Share Price of
 Shengli Oil & Gas Pipe Holdings Limited (Stock code: 01080)**

(Hong Kong – 17 December 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Shengli Oil & Gas Pipe Holdings Limited** (“Company”; stock code: 01080) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for the Company on PhillipMart were HK\$2.41 and HK\$2.12. The price closed at HK\$2.38 per share, 8.18% higher than its offer price of HK\$2.20. The price opened at HK\$2.20, with the most actively traded price of HK\$2.30 per share, and a turnover of 2,748,000 shares. The total trading volume reached 15,420,000 shares with total turnover of HK\$35,772,975.00. The final price of the Company, to debut trading tomorrow has been fixed at HK\$2.20 per share.
