

PhillipMart Announces Pre-IPO Share Price of China Pacific Insurance (Group) Co., Ltd. (Stock code: 02601)

(Hong Kong – 22 December 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Pacific Insurance (Group) Co., Ltd.** ("China Pacific Insurance"; stock code: 02601) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Pacific Insurance on PhillipMart were HK\$28.00 and HK\$27.30. The price closed at HK\$27.80 per share, 0.71% lower than its offer price of HK\$28.00.
