

**PhillipMart Announces Pre-IPO Share Price of
 Hontex International Holdings Company Limited (Stock code: 00946)**

(Hong Kong – 23 December 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Hontex International Holdings Company Limited** (“Hontex International”; stock code: 00946) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Hontex International on PhillipMart were HK\$2.29 and HK\$2.15. The price closed at HK\$2.18 per share, 1.40% higher than its offer price of HK\$2.15.
