

**PhillipMart Announces Pre-IPO Share Price of  
 Carpenter Tan Holdings Limited (Stock code: 00837)**

(Hong Kong – 28 December 2009) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Carpenter Tan Holdings Limited** (“Carpenter Tan”; stock code: 00837) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Carpenter Tan on PhillipMart were HK\$3.26 and HK\$2.90. The price closed at HK\$3.24 per share, 25.58% higher than its offer price of HK\$2.58. The price opened at HK\$2.90, with the most actively traded price of HK\$3.15 per share, and a turnover of 668,000 shares. The total trading volume reached 3,748,000 shares with total turnover of HK\$11,836,280.00. The final price of Carpenter Tan, to debut trading tomorrow has been fixed at HK\$2.58 per share.
