

PhillipMart Announces Pre-IPO Share Price of Schramm Holding AG (Stock code: 00955)

(Hong Kong – 28 December 2009) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Schramm Holding AG** ("Schramm"; stock code: 00955) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Schramm on PhillipMart were HK\$43.15 and HK\$41.05. The price closed at HK\$41.95 per share, 13.38% higher than its offer price of HK\$37.00. The price opened at HK\$42.00, with the most actively traded price of HK\$41.80 per share, and a turnover of 16,320 shares. The total trading volume reached 131,920 shares with total turnover of HK\$5,523,636.00. The final price of Schramm, to debut trading tomorrow has been fixed at HK\$37.00 per share.
