

**PhillipMart Announces Pre-IPO Share Price of
 Meike International Holdings Limited (Stock code: 00953)**

(Hong Kong – 28 January 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Meike International Holdings Limited** (“Meike International”; stock code: 00953) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Meike International on PhillipMart were HK\$1.48 and HK\$1.37. The price closed at HK\$1.38 per share, 3.50% lower than its offer price of HK\$1.43. The price opened at HK\$1.43, with the most actively traded price of HK\$1.45 per share, and a turnover of 938,000 shares. The total trading volume reached 3,488,000 shares with total turnover of HK\$4,990,740.00. The final price of Meike International, to debut trading tomorrow has been fixed at HK\$1.43 per share.
