

PhillipMart Announces Pre-IPO Share Price of Ruinian International Limited (Stock code: 02010)

(Hong Kong – 18 February 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Ruinian International Limited** ("Ruinian International"; stock code: 02010) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Ruinian International on PhillipMart were HK\$3.13 and HK\$3.05. The price closed at HK\$3.13 per share, 4.33% higher than its offer price of HK\$3.00. The price opened at HK\$3.05, with the most actively traded price of HK\$3.12 per share, and a turnover of 128,000 shares. The total trading volume reached 364,000 shares with total turnover of HK\$1,133,060.00. The final price of Ruinian International, to debut trading tomorrow has been fixed at HK\$3.00 per share.
