PhillipMart Announces Pre-IPO Share Price of Z-Obee Holdings Limited (Stock code: 00948)

(Hong Kong – 26 February 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Z-Obee Holdings Limited** ("Z-Obee"; stock code: 00948) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Z-Obee on PhillipMart were HK\$1.90 and HK\$1.80. The price closed at HK\$1.84 per share, 2.22% higher than its offer price of HK\$1.80. The price opened at HK\$1.86, with the most actively traded price of HK\$1.80 per share, and a turnover of 846,000 shares.
