

**PhillipMart Announces Pre-IPO Share Price of
 Huiyin Household Appliances (Holdings) Co., Ltd (Stock code: 01280)**

(Hong Kong – 24 March 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Huiyin Household Appliances (Holdings) Co., Ltd** (“Huiyin Household Appliances”; stock code: 01280) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Huiyin Household Appliances on PhillipMart were HK\$2.31 and HK\$2.01. The price closed at HK\$2.29 per share, 35.50% higher than its offer price of HK\$1.69. The price opened at HK\$2.08, with the most actively traded price of HK\$2.30 per share, and a turnover of 950,000 shares. The total trading volume reached 10,592,000 shares with total turnover of HK\$23,506,440.00. The final price of Huiyin Household Appliances, to debut trading tomorrow has been fixed at HK\$1.69 per share.
