

## PhillipMart Announces Pre-IPO Share Price of Zhongsheng Group Holdings Limited (Stock code: 00881)

(Hong Kong – 25 March 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Zhongsheng Group Holdings Limited** ("Zhongsheng Group"; stock code: 00881) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Zhongsheng Group on PhillipMart were HK\$10.00 and HK\$9.60. The price closed at HK\$9.94 per share, 0.60% lower than its offer price of HK\$10.00. The price opened at HK\$9.60, with the most actively traded price of HK\$9.63 per share, and a turnover of 62,000 shares.
