

PhillipMart Announces Pre-IPO Share Price of Far East Global Group Limited (Stock code: 00830)

(Hong Kong – 29 March 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Far East Global Group Limited** ("Far East Global"; stock code: 00830) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Far East Global Group Limited on PhillipMart were HK\$1.36 and HK\$1.29. The price closed at HK\$1.31 per share, 11.02% higher than its offer price of HK\$1.18. The price opened at HK\$1.30, with the most actively traded price of HK\$1.30 per share, and a turnover of 716,000 shares. The total trading volume reached 2,258,000 shares with total turnover of HK\$2,964,320.00. The final price of Far East Global, to debut trading tomorrow has been fixed at HK\$1.18 per share.
