## PhillipMart Announces Pre-IPO Share Price of Fook Woo Group Holdings Limited (Stock code: 00923)

(Hong Kong – 30 March 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Fook Woo Group Holdings Limited** ("Fook Woo Group"; stock code: 00923) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Fook Woo Group on PhillipMart were HK\$3.01 and HK\$2.75. The price closed at HK\$2.91 per share, 26.52% higher than its offer price of HK\$2.30. The price opened at HK\$2.75, with the most actively traded price of HK\$2.90 per share, and a turnover of 2,366,000 shares. The total trading volume reached 16,428,000 shares with total turnover of HK\$47,604,520.00. The final price of Fook Woo Group, to debut trading tomorrow has been fixed at HK\$2.30 per share.
