

**PhillipMart Announces Pre-IPO Share Price of  
 Man Wah Holdings Limited (Stock code: 01999)**

(Hong Kong – 8 April 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Man Wah Holdings Limited** (“Man Wah”; stock code: 01999) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Man Wah on PhillipMart were HK\$7.80 and HK\$7.40. The price closed at HK\$7.80 per share, 14.71% higher than its offer price of HK\$6.80. The price opened at HK\$7.50, with the most actively traded price of HK\$7.80 per share, and a turnover of 52,400 shares. The total trading volume reached 105,600 shares with total turnover of HK\$808,268.00. The final price of Man Wah, to debut trading tomorrow has been fixed at HK\$6.80 per share.
