

## PhillipMart Announces Pre-IPO Share Price of Lansen Pharmaceutical Holdings Limited (Stock code: 00503)

(Hong Kong – 6 May 2010) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Lansen Pharmaceutical Holdings Limited** ("Lansen Pharmaceutical"; stock code: 00503) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Lansen Pharmaceutical on PhillipMart were HK\$5.04 and HK\$4.66. The price closed at HK\$5.00 per share, 27.88% higher than its offer price of HK\$3.91. The price opened at HK\$5.00, with the most actively traded price of HK\$4.80 per share, and a turnover of 777,000 shares.
