

PhillipMart Announces Pre-IPO Share Price of L'OCCITANE INTERNATIONAL S.A. (Stock code: 00973)

(Hong Kong – 6 May 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **L'OCCITANE INTERNATIONAL S.A.** ("L'OCCITANE"; stock code: 00973) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for L'OCCITANE on PhillipMart were HK\$15.12 and HK\$14.22. The price closed at HK\$14.96 per share, 0.80% lower than its offer price of HK\$15.08. The price opened at HK\$14.50, with the most actively traded price of HK\$15.00 per share, and a turnover of 1,163,500 shares. The total trading volume reached 3,666,000 shares with total turnover of HK\$54,989,230.00. The final price of L'OCCITANE, to debut trading tomorrow has been fixed at HK\$15.08 per share.
