

PhillipMart Announces Pre-IPO Share Price of Youvuan International Holdings Limited (Stock code: 02268)

(Hong Kong – 26 May 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Youyuan International Holdings Limited** ("Youyuan International"; stock code: 02268) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Youyuan International on PhillipMart were HK\$2.66 and HK\$2.58. The price closed at HK\$2.63 per share, 1.94% higher than its offer price of HK\$2.58. The price opened at HK\$2.59, with the most actively traded price of HK\$2.65 per share, and a turnover of 146,000 shares. The total trading volume reached 399,000 shares with total turnover of HK\$1,051,530.00. The final price of Youyuan International, to debut trading tomorrow has been fixed at HK\$2.58 per share.
