

PhillipMart Announces Pre-IPO Share Price of China Titans Energy Technology Group Co., Limited (Stock code: 02188)

(Hong Kong – 27 May 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **China Titans Energy Technology Group Co., Limited** ("China Titans"; stock code: 02188) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for China Titans on PhillipMart were HK\$1.53 and HK\$1.35. The price closed at HK\$1.52 per share, 28.81% higher than its offer price of HK\$1.18. The price opened at HK\$1.38, with the most actively traded price of HK\$1.47 per share, and a turnover of 2,078,000 shares. The total trading volume reached 10,138,000 shares with total turnover of HK\$14,783,180.00. The final price of China Titans, to debut trading tomorrow has been fixed at HK\$1.18 per share.
