

PhillipMart Announces Pre-IPO Share Price of International Taifeng Holdings Limited (Stock code: 00873)

(Hong Kong – 10 June 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **International Taifeng Holdings Limited** ("International Taifeng"; stock code: 00873) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for International Taifeng on PhillipMart were HK\$2.00 and HK\$1.92. The price closed at HK\$1.92 per share, 6.80% lower than its offer price of HK\$2.06. The price opened at HK\$2.00, with the most actively traded price of HK\$1.92 per share, and a turnover of 336,000 shares.
