

**PhillipMart Announces Pre-IPO Share Price of  
 Costin New Materials Group Limited (Stock code: 02228)**

(Hong Kong – 18 June 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Costin New Materials Group Limited** (“Costin”; stock code: 02228) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Costin on PhillipMart were HK\$2.43 and HK\$2.38. The price closed at HK\$2.39 per share, 0.42% higher than its offer price of HK\$2.38. The price opened at HK\$2.38, with the most actively traded price of HK\$2.41 per share, and a turnover of 289,000 shares. The total trading volume reached 578,000 shares with total turnover of HK\$1,394,700.00. The final price of Costin to debut trading tomorrow has been fixed at HK\$2.38 per share.
