

## PhillipMart Announces Pre-IPO Share Price of Trauson Holdings Company Limited (Stock code: 00325)

(Hong Kong – 28 June 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Trauson Holdings Company Limited** ("Liansu"; stock code: 00325) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Trauson on PhillipMart were HK\$3.88 and HK\$3.65. The price closed at HK\$3.84 per share, 9.09% higher than its offer price of HK\$3.52. The price opened at HK\$3.70, with the most actively traded price of HK\$3.69 per share, and a turnover of 967,000 shares. The total trading volume reached 5,332,000 shares with total turnover of HK\$19,885,150.00. The final price of Trauson to debut trading tomorrow has been fixed at HK\$3.52 per share.
