## PhillipMart Announces Pre-IPO Share Price of Guotai Junan International Holdings Limited (Stock code: 01788)

(Hong Kong – 7 July 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Guotai Junan International Holdings Limited** ("Guotai Junan"; stock code: 01788) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Guotai Junan on PhillipMart were HK\$4.25 and HK\$3.98. The price closed at HK\$4.15 per share, 3.49% lower than its offer price of HK\$4.30. The price opened at HK\$4.20, with the most actively traded price of HK\$4.20 per share, and a turnover of 460,000 shares. The total trading volume reached 1,699,000 shares with total turnover of HK\$7,007,750.00. The final price of Guotai Junan to debut trading tomorrow has been fixed at HK\$4.30 per share.
