

**PhillipMart Announces Pre-IPO Share Price of
 China ITS (Holdings) Co., Ltd (Stock code: 01900)**

(Hong Kong – 14 July 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **China ITS (Holdings) Co., Ltd** (“ITS”; stock code: 01900) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for ITS on PhillipMart were HK\$3.85 and HK\$3.75. The price closed at HK\$3.76 per share, 7.74% higher than its offer price of HK\$3.49. The price opened at HK\$3.80, with the most actively traded price of HK\$3.77 per share, and a turnover of 2,102,000 shares. The total trading volume reached 6,684,000 shares with total turnover of HK\$25,266,870.00. The final price of ITS to debut trading tomorrow has been fixed at HK\$3.49 per share.
