

PhillipMart Announces Pre-IPO Share Price of Manta Holdings Company Limited (Stock code: 00936)

(Hong Kong – 16 July 2010) **Phillip Securities** (**HK**) **Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Manta Holdings Company Limited** ("Manta"; stock code: 00936) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Manta on PhillipMart were HK\$1.10 and HK\$1.08. The price closed at HK\$1.08 per share, 8.00% higher than its offer price of HK\$1.00. The price opened at HK\$1.08, with the most actively traded price of HK\$1.08 per share, and a turnover of 250,000 shares.
