

**PhillipMart Announces Pre-IPO Share Price of
 Bright Smart Securities & Commodities Group Limited (Stock code: 01428)**

(Hong Kong – 24 Aug 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Bright Smart Securities & Commodities Group Limited** (“Bright Smart”; stock code: 01428) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Bright Smart on PhillipMart were HK\$1.76 and HK\$1.63. The price closed at HK\$1.60 per share, 10.00% higher than its offer price of HK\$ 1.60. The price opened at HK\$1.70, with the most actively traded price of HK\$1.68 per share, and a turnover of 4,500,000 shares. The total trading volume reached 14,508,000 shares with total turnover of HK\$ 24,570,900.00. The final price of Bright Smart, to debut trading tomorrow has been fixed at HK\$1.60 per share.
