## PhillipMart Announces Pre-IPO Share Price of Midas Holdings Limited (Stock code: 01021)

(Hong Kong – 5 Oct 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Midas Holdings Limited** ("Midas"; stock code: 01021) on PhillipMart, an automated electronic platform for pre-IPO shares trading.
