

PhillipMart Announces Pre-IPO Share Price of SITC International Holdings Company Limited (Stock code: 01308)

(Hong Kong – 5 Oct 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **SITC International Holdings Company Limited** ("SITC"; stock code: 01308) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for SITC on PhillipMart were HK\$4.85 and HK\$4.64. The price closed at HK\$4.67 per share, -2.30% lower than its offer price of HK\$4.78. The price opened at HK\$4.85, with the most actively traded price of HK\$4.68 per share, and a turnover of 265,000shares. The total trading volume reached 882,000shares with total turnover of HK\$4,160,020.00. The final price of SITC, to debut trading tomorrow has been fixed at HK\$4.78 per share.
