

PhillipMart Announces Pre-IPO Share Price of Xinjiang Goldwind Science & Technology Co., Ltd.(Stock code: 02208)

(Hong Kong – 07 Oct 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Xinjiang Goldwind Science & Technology Co., Ltd.** ("GoldWind"; stock code: 02208) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for GoldWind on PhillipMart were HK\$19.02 and HK\$18.10. The price closed at HK\$18.98 per share, 5.56% higher than its offer price of HK\$17.98. The price opened at HK\$18.10, with the most actively traded price of HK\$18.70 per share, and a turnover of 689,800 shares. The total trading volume reached 5,239,000 shares with total turnover of HK\$98,043,992. The final price of GoldWind, to debut trading tomorrow has been fixed at HK\$17.98 per share.
