

**PhillipMart Announces Pre-IPO Share Price of  
 Winsway Coking Coal Holdings Limited (Stock code: 01733)**

(Hong Kong – 08 Oct 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Winsway Coking Coal Holdings Limited** (“Winsway”; stock code: 01733) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Winsway on PhillipMart were HK\$3.87 and HK\$3.50. The price closed at HK\$3.62 per share, -2.16% lower than its offer price of HK\$3.70. The price opened at HK\$3.80, with the most actively traded price of HK\$3.78 per share, and a turnover of 437,000shares. The total trading volume reached 9,106,000shares with total turnover of HK\$33,143,570.00. The final price of Winsway, to debut trading at 11Oct, 2010, it has been fixed at HK\$3.70 per share.
