

**PhillipMart Announces Pre-IPO Share Price of
 Great Harvest Maeta Group Holdings Limited (Stock code: 03683)**

(Hong Kong – 8 Oct 2010) **Phillip Securities (HK) Ltd.** (“Phillip Securities”) announced today the details of pre-IPO trading activities for shares of **Great Harvest Maeta Group Holdings Limited** (“Great harvest Maeta”; stock code: 03683) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Great harvest Maeta on PhillipMart were HK\$1.41 and HK\$1.25. The price closed at HK\$1.35 per share, 19.47% higher than its offer price of HK\$1.13. The price opened at HK\$1.35, with the most actively traded price of HK\$1.31 per share, and a turnover of 2,490,000 shares.
