## PhillipMart Announces Pre-IPO Share Price of Boer power Holdings Limited (Stock code: 01685)

(Hong Kong – 19Oct 2010) **Phillip Securities (HK) Ltd.** ("Phillip Securities") announced today the details of pre-IPO trading activities for shares of **Boer power Holdings Limited** ("Boer power"; stock code: 01685) on PhillipMart, an automated electronic platform for pre-IPO shares trading.

Pre-IPO highest and lowest trading prices for Boer power on PhillipMart were HK\$7.50 and HK\$7.02. The price closed at HK\$7.31 per share,14.58 % higher than its offer price of HK\$6.38 . The price opened at HK\$7.05, with the most actively traded price of HK\$7.35 per share, and a turnover of 667,000shares. The total trading volume reached 6,197,000shares with total turnover of HK\$45,541,570.00. The final price of Boer power, to debut trading tomorrow has been fixed at HK\$6.38 per share.
